Quality, Patient Safety and Efficiencies

- **Fall Prevention** – The AvaSure monitoring system went live. Preliminary data on patient numbers and number of falls since implementation will be presented. The Clinical Informatics team implemented improvements in the documentation screens for Fall Risk patients and assessment of Venous Thromboembolism (VTE) prophylaxis. These were two identified issues from the Nurse Excellence Committee that will improve accuracy and consistency of documentation in the EMR.
- **Professional Practice/Shared Governance** – We are closing in on the deadline for you to complete the information on your HealthStream Professional Portfolio to help the organization track degrees and certifications. If you need any support in completing your portfolio, please contact your manager or the clinical expert in your area. I hope everyone enjoyed the PPM mouse pads – the model is a reminder to help you connect your practice with our mission, vision and values.
- **Celebrating one of our clinical nurse experts** Julie Vasher, CNS, published in the TJC Journal on Obstetric safety bundles, consisting of action steps shown to improve outcomes, that have been developed to address the most common and preventable causes of maternal morbidity and mortality. Implementing these best practices across all birthing facilities remains an important and challenging clinical and public health priority. The conclusion of this mentor model was successful in providing individualized support to teams and enabled implementation of the hemorrhage safety bundle across a diverse group of 126 hospitals.





Hi **Dani [Robison]**,

I hope this email finds you well. I just wanted to pass on some good words about a case I had on Thursday night. I had my first vaginal twin delivery, and it was a tough case because this patient pushed for a very long time. It was an exhausting night for the patient and myself, but the whole situation was handled wonderfully and I wanted to make sure I expressed my appreciation for the support that was given to me and to my patient.

Kathy- **Kathy [Blazek]** was charge, and she did a great job keeping everything under control and ensuring that I always had support when I needed it, since I was stuck in my patient's room and in the OR most of the night. She kept things moving smoothly.

Maria [Marron]- She came into the OR with me and did some charting for me, since we were in there for 3 hours and my main role was supporting my patient through her pushing. This patient was very tired and needed A LOT of encouragement and direction, and she and I had a good rapport, so my priority was to be at her side. **Maria [Marron]** charted and helped to get materials we needed, which was a huge help.

Nina- **Nina [Perez]** stood on the other side of the patient and helped push with her and coach her alongside me for the full 2 hours it took for baby B to be delivered. Her support was greatly appreciated!

Meri- **Meri [Zaumseil]** came in from standby from 1900-2300 and since she didn't have a patient, her main role was to help me since it was my first vaginal twin delivery. We all expected this patient to deliver quickly, before 2300, so **Meri [Zaumseil]** answered all my questions about the process and helped me get things set up. **Meri[Zaumseil]** is always so patient with my questions and always supports me; she's awesome!

Michelle [Balco]/Sonia [Almazan]- They had other patient assignments/OBED, but both checked in on me frequently to see how I was doing and if they could assist in any way, which was nice!

NICU/RT- I'm sorry I don't know their names, but they were in the OR for 2 hours waiting for baby B, and instead of just waiting outside the door, they were coaching and encouraging my patient every time she pushed. I even heard cheering to try and motivate the patient, and I think the extra motivation helped a lot!

DD- **DD [Rauber]** was very understanding the next morning that I didn't have a lot done in terms of recovery and having her room ready, since it was an exhausting night and baby B was a change of shift delivery. She had the

patient the day before and knew her well, and she knew how difficult the delivery was going to be. **DD [Rauber]** hugged me in the morning after baby B was born, and that hug really made me feel great- it was like we won the championships after the long night we had when that second baby was finally born!

Finally, and perhaps the biggest kudos of the night, was to **Dr. Noel**. **Dr. Noel** was not on call, she had just decided to stay and manage my patient and deliver her. I'm sure she had hoped that she could sleep a couple hours then be called to deliver quickly and easily, because that's what we all expected. However, that wasn't the case. For whatever reason, the second stage of labor took a very long time for this patient. **Dr. Noel** was at the bedside pushing with this patient, at the perineum, for what was close to 3 hours before we even moved to the OR. She did not have to do that, I could have pushed with the patient myself, but **Dr. Noel** felt responsible to help facilitate the patient's strong desire to deliver vaginally. Both babies were healthy and the patient was afebrile, so **Dr. Noel** was patient and supportive in the patient's desire to keep pushing. Some MD's may not be so patient, especially when **Dr. Noel** wasn't even supposed to be on call. She could have easily signed out to the hospitalist for the night, since she was in the office the following day, but she felt responsible and accountable for this patient, and also knew the hospitalist was busy with OB triage all night. When I mentioned how difficult the night must be for her, she just smiled, shrugged, and said, "I made my own choices." I thought that was really classy of her, because I'm sure she was as tired and somewhat frustrated as the rest of us. She was patient, easy to work with, and encouraging. The patient was really happy. I don't know if there's an equivalent of the Daisy Award for physicians, but if there is, I would like to nominate **Dr. Noel**. I think she flies under the radar since she's so quiet, and relatively new, but I have had nothing but great experiences with her and she's an awesome OB.

Sorry for the long email, but now that I'm home and I've had time to reflect (and sleep!), I wanted to be sure to express how grateful I am for our team. This case wasn't an emergency situation or anything like that, but it was a case that required a lot of hands and even more support, both physically and emotionally for the patient. She had 2 healthy babies vaginally after a very long labor, and it was a success all around. Thanks for taking the time to read all this, I appreciate it!


